2019-20: A year of partnership and adaptation

Launch of the North Toronto Ontario Health Team

This year, SPRINT Senior Care took its hospital and community partnerships to a new level. In the fall of 2019, we submitted an extensive application to the Ministry of Health to establish an Ontario Health Team (OHT) with our North Toronto partners: Baycrest, LOFT Community Services, Toronto Central LHIN, SE Health, Sunnybrook Health Sciences Centre, Unison Health and Community Services, VHA Home Healthcare, Vibrant Healthcare Alliance, primary care providers, and local clients, patients, families, and caregivers.

On December 4th, 2019, it was announced that the North Toronto OHT application was officially approved by the Ministry of Health. Starting in 2020, this group of health providers started working closely to plan for how to provide a connected system of health care for people living and seeking care in North Toronto.

When we work together with partner organizations, we ensure that people are accessing the right care when they need it the most. Our transitional care home, Pine Villa, is a strong example of this. The 68-bed facility on

Eglinton Ave. W, which launched in 2018, helps people transition from hospital to home, and is a collaboration between SPRINT Senior Care, Sunnybrook Health Sciences Centre, and LOFT Community Services. Since 2018, we have successfully transitioned 195 clients through Pine Villa.

We look forward to building on the Pine Villa experience to help direct the work with our North Toronto OHT partners during the 2020-21 year, and to work toward the development of a seamless and integrated health care system that is centred around the needs of clients and caregivers.

COVID-19 and the launch of our Community Response Team

Due to the unprecedented impact of the COVID-19 pandemic, we took immediate and decisive steps this winter to ensure the health and safety of our staff, volunteers, clients, and families.

In February, we began agency-wide client, visitor, and staff screening. In March, several of our non-essential services were suspended, reduced, or adapted to be virtual. This included the temporary suspension of our Adult Day Program and our in-person Community Wellness programs, which continue to be on hold as we begin the 2020-21 year.



To meet the new and urgent needs of seniors during the pandemic, we redeployed staff to support our new COVID-19 Community Response Team, an initiative we nimbly launched in March. Our

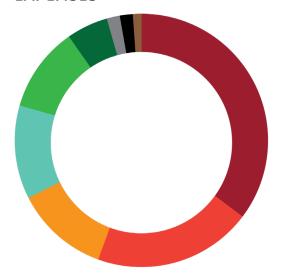
Community Response Team is dropping off food, groceries, and other essential items to seniors' doorsteps; conducting wellness checks over the phone; and delivering virtual exercise and social programs over Zoom, YouTube, and teleconference. These programs are ensuring that local seniors remain healthy, safe, and social during these difficult times. Thanks to funding from the United Way Greater Toronto, the Government of Canada's New Horizons for Seniors program, the Ontario Government, the Ontario Community Support Association, and many generous private donors, we have been able to launch these programs and keep them running.

As we move into 2020-21, we are optimistic about the year ahead. Our most significant challenge will be adapting our programs and services as the COVID-19 pandemic continues, but we are confident in our ability to respond to our clients' needs. Additionally, we look forward to collaborating with our North Toronto OHT partners to create new COVID-19-related protocols. We have no doubt that sharing our knowledge and working together with this team will lead to positive and progressive outcomes.

SPRINT Senior Care extends our sincere gratitude to our 2019-20 donors for enabling us to care for those in need. You have made a difference in the lives of seniors.

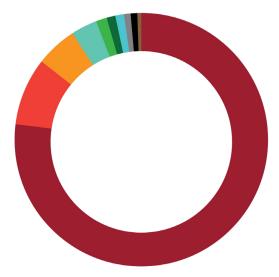
